

Industry Highlights

- The fire and life safety market has experienced, and is expected to continue realizing, outsized growth. This growth can be attributed to increased building activities (both new structures requiring new systems and the repair/replacement of existing infrastructure and technologies and adoption of advancements in technologies to prevent, detect, and respond to fire and life safety related incidents. The industry outlook is supporting secular growth trends, while a \$10 billion+ market size provides opportunities for platforms to accelerate growth through M&A. Key focus areas for strategic and sponsor backed acquisitions continue to focus on additional service lines, new geographic regions, expanding technological capabilities, and regulatory drivers.in the U.S.On May 30, 2023, Full-service fire and life safety platform Altus, backed by private equity firm AE Industrial Partners, announced its acquisition of Crime Intervention Alarm. CIA is an installation, monitoring, inspection and service provider for security and surveillance systems, access control and fire systems that operates out of York, PA, and the greater mid-Atlantic region.
- On May 10, 2023, Pavion (formerly Corbett Technology Solutions, Inc.), a leading provider of integrated solutions for fire, safety, security, and critical communications, acquired Premier Security Solutions. This acquisition expands Pavion's US western region fire alarm and security services.
